#### 3. Program Updates

Williams and Herrera provided updates on the Syringe Services Program activities and August monthly data. Participant usage, syringe distribution and collection via the exchange has declined. Kiosk disposal of syringes has increased compared to August 2020 data. Program staff have increased efforts regarding education and referrals. HIV/HCV test target date moved from October to November. Watsonville participant exchange surveys are scheduled for October. Commission discussed SSP program data and outreach methods. Commissioners also discussed the Harm Reduction Coalition (HRC) data and services.

#### 4. Presentations

Williams presented on International Overdose Awareness Day, (August 31, 2021). (Erroneously listed as National Overdose Awareness Day on the posted agenda). The Harm Reduction Coalition and Safe Rx held a virtual and in-person event at Community Bridges in Watsonville from 4:30-6pm. Williams also presented on Narcan distribution and Narcan training. Narcan is offered at every exchange. Presentation included signs of overdose and dispelled common myths about administering Narcan. The SSP program has distributed nearly 900 doses of Narcan (in both injectable and nasal forms) during 2021. Participants reported 199 overdoses reversed from January through the end of August 2021.
