Encompass provided an overview of their services, overview of their principles and what has changed since the launch of DMC-ODS services. Provide evidence practices such as the Matrix model, Seeking Safety, and Motivational Interviewing. Included summary of Residential, Outpatient and MAT services. Serve approximately 360 clients in residential annually. Some of their challenges in FY19-20 include: COVID-19 response and management, staff recruitment and retention, did not make productivity challenges due to COVID. Reviewed client satisfaction surveyed. Overall results outpatient surveys are 94-100% satisfaction across multiple domains. Overall results for residential services were 94%-99% satisfied.

Encompass asked for SUDC support in terms of funding support for housing and MAT. Encompass also asked for ideas around staff retention.

Colleen asked Susie for feedback regarding support for homeless persons. Response was that housing is a challenge. SLE's and permanent supportive housing are in short supply but always worth the pursuit. Encompass has long standing relationship with Housing Matters.

Susie: Potential agenda item to invite workforce investment board to see if they are integrating their work with community-based programs. Regarding housing Susie thinks it would be great to invite Housing for Health Director, Rob Ratner to discuss integration with our systems of care and housing response.

Josee asked if Encompass accessed in rental assistance related grants for housing support. Response from Encompass was that we didn't use rental assistance related grants but did utilize hotel voucher program.

Jozee: ideas/questions: Have you thought about offering detox/withdrawal management beds?

Erin: Encompass has been discussing it, the financial aspects is an important part as well as staffing.

Will: Discussions are as far as things have gotten

Jozee – very strong need in the community, can't say for sure but funding may be available.

Jozee has been thinking about the need for transportation that could run in parallel with housing support. Thinking the benefits of a program for vehicle donation that people transitioning who are in need of a car. Very empowering to have a vehicle and can help with motivation.

Christine: Did Encompass apply for an FEMA related assistance?

Erin: Did not apply for FEMA but did access CARE funding to support programs.

Susie – as we hopefully transition out of the most severe aspects of the pandemic, it's come to her attention that vaccination rates in homeless camps are really low. What are requirements at Encompass in terms of vaccine?

Encompass response that vaccination percentages are really high amongst staff. As clients enter their program, they are offered the vaccination and support getting them connected.

Susie offered to connect Encompass with HPHP staff to see how they can help with vaccinations.

Susie – nothing to report
